Inspection of kennel took place on April 17, 2009. A total of 208 adult dogs and 116 puppies were located on the premises at the time of inspection. The 2008 kennel license was viewed. This warden also viewed the rabies self certification letter and exemption letter allowing the owner to keep records on "unofficial" forms. Inspection was performed with SDWS Drew Delenick, SDW Kristen Reed, and a Veterinarian.

One adult Doberman Pincher male "Feddo" had a nickel-sized open draining lesion above his right eye. One adult Standard Poodle male, "Remington", had a possible ear infection, evidenced by the dog shaking his head frequently and odor emanating from his ears. One adult Greyhound female, "Dusty", had a large area of alopecia on her dorsal midline. The area was erythematous, surrounded by yellow crusts, and had many red raised lesions. One adult Pit Bull Terrier female, "Evie", had several alopecic areas on her body. She had areas of thinning hair over her right shoulder, on her dorsal midline, and on her flanks bilaterally. The underlying dermis in all areas was hyperpigmented and erythematous. One Poodle puppy female, "Flashes litter", appeared depressed although, responsive while the rest of the puppies in the litter were bright, alert, and active. The puppy had slightly pale mucous membranes. A delayed skin turgor test indicated that the puppy may also be slightly dehydrated.

Two poodle puppies located in the kennel displayed signs of possible dehydration, lethargy, and had bloody diarrhea. One Chihuahua puppy was thin and showed signs of lethargy (kennel owner giving subcutaneous fluids). One poodle, "Toby", showed signs of lameness in his front left leg.

Many dogs were in need of being groomed for being matted.

This warden directs the kennel owner take the following action(s):

The dogs listed in the above aforementioned paragraph all exhibit signs of poor health; kennel owner shall provide proof of adequate veterinary care for each dog listed above.

402 (d)

Veterinary examinations were ordered on (4) dogs under section 402(a) based on wardens observations of the condition of dogs during an inspection. Kennel in compliance with section 402(d) because veterinary examinations were completed within the 72 hour time frame.

Owner had an adult female Boxer "Marci" listed on his breeder records and on the puppy records had listed Marci Boxer pups (4) as being born on 5/13/09 indicating Marci was breed after the Notice of Operating Under Suspension was served. (Charges to follow)

This warden directs kennel owner take the following action(s):

While operating under a suspended license, the kennel owner may not breed any dogs.
