There was one dead rat in run with dogs and a live rat there being attacked by the dogs. 21.21c Drainage needs fixed again: there were 4 pens with standing water and/ or urine puddles. 21.22 Dogs displaying aggressive behavior to be inaccessible to other dogs; there were two pens were fighting was going on, one pen had blood in the run area outside and two dogs with marks on them. The other had a dog with a noticeable healing slit in its nose.
