Owner still owns/possesses/keeps two adult dogs that he acquired since the Notice of Operating Under Suspension.

While operating under a suspended license, the kennel owner may not acquire any additional dogs by any means, including breeding. \*CHARGES TO FOLLOW\*

Misc.:

The pregnant female from the previous inspection was only viewed from a distance and was not found at any other time throughout the inspection. This warden requested the kennel owner obtain this dog, and showed him a photograph to be sure he knew which dog to look for, so that the veterinarian could view the dog closely enough to examine. The kennel owner told this warden and those assisting that he did not know where the dog was and this warden and the other were free to look for her. When asked where the dog's puppies were the kennel owner only stated that he did not see any pups so how would he know where they are.
