SEVERAL KENNES ARE IN NEED OF REPAIR- CITATIONS TO FOLLOW

21.21b Water Resistance  
ALL WOOD INSIDE KENNEL AREA MUST BE TREATED, PAINTED OR COVERED-CITATIONS TO FOLLOW

21.21c Drainage  
EXCESS WATER MUST ADEQUATELY DRAIN FROM AREAS WHERE DOGS ARE HOUSED-CITATIONS TO FOLLOW

21.24b Bedding  
SUFFICIENT BEDDING MUST BE PROVIDED FOR DOGS KEPT OUTDOORS.-CITATIONS TO FOLLOW

21.24d Rest Area  
FLOORING MUST BE ADEQUATE TO NOT ALLOW THE ANIMALS FEET TO PASS THROUGH THE OPENINGS- CITATIONS TO FOLLOW

21.25a Temperature  
TEMPERATURE MUST BE MAINTAINED AT A LEVEL TO PROTECT TE HEALTH AND COMFORT OF ANY DOGS -CITATIONS TO FOLLOW

21.26 Ventilation  
PROPER VENTILATION MUST BE INSTALLED TO MINIMIZE ODORS.

21.27 Lighting  
PROPER LIGHTING MUST BE INSTALLED IN ORDER TO ALLOW THE OBSERVATION OF THE ANIMALS CONDITION

21.28a Food  
FOOD SHALL BE KEPT FREE OF CONTANIMATION

21.28c Food/Water Receptacles  
FOOD AND WATER RECEPTACLES SHALL BE CLEANED A MINIMUM OF ONCE DAILY

21.29a Excreta  
ALL EXCRETA MUST BE REMOVED FROM THE PRIMARY ENCLOSURE AND ANY FLOOR AREA

21.29b Sanitation  
KENNELS MUST BE SANITIZED A MINIMUM OF ONCE DAILY

21.29c Housekeeping/Pests  
GROUNDS OF THE KENNEL MUST BE KEPT CLEANED

21.41a Records Kept  
STATE RECORDS MUST BE AVAILABLE FOR OBSERVATION

LICENSE WAS SURRENDERED TO WARDEN. KENNEL WAS INSPECTED BY WARDEN ORLANDO AGUIRRE AND ED BUNT. HUMANE OFFICERS WERE PRESENT BOTH INSPECTIONS BUT WERE NOT PERMITTED TO WALK THROUGH MR.
