Remarks

Re-inspection of kennel took place on November 24, 2008. A total of 159 adult dogs and 50 puppies were located on the premises at the time of inspection. Exemption letter allowing owner to keep records on "unofficial" forms was viewed. Inspection was performed with Drew Delenick, and Mike Zeigler.

*** Actions directed to be taken below are not all that may be required of the kennel operator to come into compliance. The kennel operator is responsible for taking any and all actions necessary to come into compliance.

The inspection of November 24, 2008 is as follows:

21.21 (a) -

Pen # 1 in whelping room has wire roofing that was not secured. The dog in the pen was able to stick its head out of the pen where the wire was not secured and the sharp edges of the wire come into contact with the dog. Pen # 41 has a small piece of broken wire which can come into contact with the dog. (warning issued)

This Warden directs the kennel owner take the following action(s):

Eliminate the sharp piece of wire in pen #41 by snipping it off the pen. The wire roof on pen # 1 should be fixed by securing it to the side of the kennel on which it is attached.

21.21 (b) -

Whelping room has scratched and chewed wood which is not currently water sealed. Kennel has wire pens where coating has come off the sides and the wire has become rusty. Pen numbers 43, 44, 45, 46 are specifically noted as being significantly rusty. Other wire throughout the kennel also shows signs of rust. (Charges to follow)

This Warden directs the kennel owner take the following action(s):

All scratched and chewed wood needs to be water sealed. All rusty wire which is found in the kennel and can come into contact with dogs needs to have the rust removed and painted or the wire replaced.

21.22 -

At time of inspection, dogs in pen # 49 were participating in a dog fight. (warning issued)

This Warden directs the kennel owner take the following action(s):

The dogs in the pen in question which show aggression to each other must be placed in pens where they cannot come into contact with each other.

21.28 (a) -

Two automatic feeders in the whelping room were contaminated with feces. In main kennel area feces were found the feeders in pen numbers 3, 7, and 48 which contaminated the food inside. (Charges to follow)

This Warden directs the kennel owner take the following action(s):

Automatic feeders and food need checked daily for feces and other food contamination.

21.28 (c) -

Several automatic feeders found through out the kennel were contaminated with feces. Several other automatic feeders were dirty with caked food, dirt, and hair. (Charges to follow).

This Warden directs the kennel owner take the following action(s):

Automatic feeders need to be checked for feces on a daily basis and need to be sanitized on a regular basis to prevent the caking of feed and dirt and debris buildup.

21.29 (b) -

This warden noted several pens which have a build up of hair and dirt on wire with which dogs can come into contact. There were also cross members noted that had dried feces which could also come into contact with dogs. (warning issued)

This Warden directs the kennel owner take the following action(s):

Pens and cross members need to be sanitized a minimum of once daily or as often as necessary to prevent build up of dirt, debris, hair, and dried feces in kennel pens where dogs can come into contact with.

21.29 (c) -

This warden noted several pens which had a build up hair and cobwebs. There were also areas of the kennel that had feces of either mice or rats. (Charges to follow)

This Warden directs the kennel owner take the following action(s):

Cobwebs and hair build up needs to be removed and the overall kennel area needs to be kept clean. Rat or mouse feces needs to be removed and some other type of pest control device needs to be put into the kennel.

21.41 (a) -

This warden noted 159 adults and 50 puppies at the time of inspection. Records showed a total of 164 adults. The same was noted for the rabies vaccination records. 159 dogs were shown to be at the kennel but the rabies records showed a total of 164 being vaccinated. Records were not completed to the numbers at kennel. (Charges to follow)

This Warden directs the kennel owner take the following action(s):

Kennel owner should remove dogs off the records and remove their rabies vaccination when they are sold or euthanized. Records need to be complete and match the numbers of dogs noted at the time of inspection.

21.30 - Dog condition

This Warden noted that many dogs had matting in the kennel. One dog was noted to have problems with its teeth. Five vet check orders were ordered at the inspection. A female adult schnauzer was noted to have raw sores on its nipple. An adult male bichon was found to have a sore on its penis. A female poodle had 2 sores on its back. An adult male bichon had a possible severe ear infection. An adult male bichon had a sore on its neck. (Charges to follow)

This kennel owner must take the dogs which have been ordered to see a vet to a vet with in 72 hours of the inspection. The kennel owner should also look for matting on his dogs and be proactive in removing the matting. The kennel owner should also be proactive in noting possible medication problems and getting the dogs in question veterinary care.
