Remarks

First inspection for 2007. There was a total of 307 adult dogs and 126 puppies on the premises at the time of inspection. Viewed exemption letter to keep records on USDA forms. Had another copy of rabies certification mailed to owner.

21.21a- Dog boxes need recaulked around edges, what is there is/ has peeled off. Fix glass board on walls of some dog pens where it has been chewed off. Metal frames around openings to outdoor runs need pushed back up.

21.23a- There was puppies in pens that were too small for the amount of dogs in them, owner fixed this on the spot. Owner was given verbal warning if this happens again he will be cited.

21.24d- Alot of dogs feet were falling through the wire flooring on the outdoor runs of kennel. The tender foot owner put in is too big, owner needs to put a mat in to cover wire or get smaller wire. The whelping pens had wire coating coming off.

21.28a- The food was contaminated by bugs in almost all of the feeders. Owner was given ideas on how to fix this.

21.28c- Feeders that have caked on feed must be cleaned.

21.29b- Dog boxes need to be cleaned better especially in corners and around the edges.

455.8- There was 50 extra rabies vaccination on the records, owner needs to go through and cross off dogs that are no longer here.

603b- Puppies were being sold under 7 weeks of age (charges to follow).

21.30- Clip dogs toenails.
