Waiting for kennel owner to return so that I can re-inspect kennel... Satisfactory inspection needed before 2007 kennel license can be sent out.

Remarks

Second inspection of 2007. Viewed current 2007 license. At the time of inspection there were 366 adults and 131 puppies on the premises.

21.21 b. In the upstairs section of the kennel there was exposed wood inside the dog boxes that needs smoothed out and resealed or painted.

21.23 b. There was three cages measured that do not meet the space requirements. Cage #20 had 6 dogs each 17 inches long that need 3.67 sq. ft. a piece and the cage was only 10 sq. ft. So this cage needs 12.02 sq. ft. more. Cage N6 had 5 dogs each 20 inches long that needs 4.69 sq. ft. a piece and the cage was only 10 sq. ft. So this cage needs 2.69 sq. ft. more. And the middle cage in the three tiered section had 4 dogs each 16 inches long that needs 3.36 sq. ft. a piece and the cage was only 10 sq. ft. So this cage needs 3.44 sq. ft. more.

21.24 d. The wire coating is coming off in many of the cages, wire coating needs repaired or replaced. Some rest mats were chewed up and need replaced.

21.28 a. There were feeders that had moldy food inside and food that had been contaminated by feces. The feces was old, hard, and turning white. Charges to follow.

21.28 c. The self feeders had feces inside them stuck to the bottom, moldy food, hair build up, and caking. Charges to follow.

21.28 d. Some the boxes which had bedding inside had an excess of feces mixed in with the bedding.

21.29 a. There was an excess of feces under the outdoor runs of new section of kennel, some of which was turning white. The owner admitted to not having cleaned for a couple of days because of a wedding. There was also feces smeared inside of dog boxes. Charges to follow.

21.29 b. The amount of feces smeared inside of the dog boxes was evidence that the boxes were not being cleaned on a daily basis. There was also a lot of hair hanging under the pens.

21.29 c. There was an excess of flies. There was a lot of hair hanging underneath the kennels which needs to be removed.

21.41 a. Owner needs to add all puppies on to his records so that they can be matched up.

455.8 There was no way to match up rabies records to dogs over three months due to problems with record keeping, owner given two weeks to fix this issue.

21.30 Condition of Dog: There were three dogs that vet checks were ordered for and other dogs need shaved down and have there toe nails clipped.

Remarks Reinspection to make sure prior unsatisfactorities have been corrected. Viewed current 2007 license. There were 389 adult dogs and 113 puppies on the premises at the time of inspection. 21.21b Exposed wood in dog boxes in whelping room needs resealed. 21.23b Cages are still not adequate in size for amount of dogs being housed. Go through and measure dogs and put the correct amount of dogs per square feet. 21.24d The wire coating on the floor is coming off and needs repaired/ replaced. Also puppies and dogs feet are falling through the wire flooring, use smaller flooring or add a rest mat. 21.28a Many feeders had feces in them. One feeder was completely filled with feces that was old and turning white. (charges to follow) 21.28c Many feeders need to be cleaned. Feeders must be kept free of excreta and caking of food. (charges to follow) 21.29c There was a dead mouse found in the upstairs indoor section of the kennel. (charges to follow) 21.41a The records are over by 18 dogs on the breeder list. 455.8 The rabies records are over by 81 dogs on the records, dogs that are no longer at kennel need to be crossed off paperwork. Reinspect kennel in two weeks.

This cage was 40 w x 79 land had 5 19" dogs. 21.24d All vinyl coating that is coming off the wire needs to be repaired/ replaced. 21.29a Three cages in the prefab section of the kennel had an excess of feces in them. 21.29b Needs to clean inside pens, cross rails, and edges of cages better. 21.41a Owner needs to go through and cross off the dogs that are no longer at the kennel. 455.8 Owner needs to cross off dogs that are no longer at the kennel and fill out the missing info. on the rabies sheets (Fort Dodge etc.)
