Remarks

Actions which are directed to be taken are not all that may be required of the kennel operator to come into compliance. The kennel operator is responsible for taking any and all actions necessary to come into compliance.

Inspection of the kennel took place October 25, 2010. A total of 251 adult dogs and 130 puppies were located on the premises at the time of the inspection. The 2010 kennel license was viewed; along with the rabies self certification letter, and state forms exemption letter. Inspection was performed with SDW Warminsky.

Inspection of October 25, 2010 is as follows:
455.8/207(b)

Wardens observed that in the kennel records there were 5 different dogs who were more than a month overdue on their rabies shots.

This warden directs that the kennel owner take the following action(s):

455.8(a) Every person in this Commonwealth, owning or keeping a dog over three months of age shall cause that dog to be vaccinated against rabies by a licensed veterinarian.

207(i)(8)

Wardens observed that kennel records indicated that the last scheduled veterinary exam was March 26, 2010 making the kennel a month overdue for their six month veterinary check.

This warden directs that the kennel owner take the following action(s):

207(i)(8) A dog shall be examined by a veterinarian at least once every six months. During the examination, the veterinarian shall use appropriate methods to prevent, control, diagnose and treat diseases and injuries.

A reinspection will occur at a later date.

Remarks

Actions which are directed to be taken are not all that may be required of the kennel operator to come into compliance. The kennel operator is responsible for taking any and all actions necessary to come into compliance.

Inspection of the kennel took place on December 22, 2010. A total of 234 adult dogs and 120 puppies were located on the premises at the time of the inspection. The kennels 2010 license was viewed; along with rabies self certification letter, and the state form exemption letter. Inspection was performed with SDW Seiple.

The inspection of December 22, 2010 is as follows:

21.24(d)/207(b)

Wardens observed puppies in several primary enclosures whose feet were passing through the metal strand flooring.

This warden directs that the kennel owner take the following action(s):

21.24(d) A dog may be sheltered in a primary enclosure having metal strand flooring provided the following conditions are met:

- (1) The metal strand flooring is coated with a vinyl type coating.
- (2) The coated metal strand flooring shall be kept in good repair.
- (3) The coated metal strand flooring shall be made of mesh construction that does not allow the dog's feet to pass through any opening in the floor and does not otherwise cause injury to the dog.
- (4) The coated metal strand flooring shall be constructed of sufficient diameter (gauge) to provide a completely rigid floor area sufficient to support the weight of dogs housed in the enclosure so that the metal strand floor does not bend or sag from the weight of the dogs.
- (5) The dogs shall be provided with a draft free area that protects the dogs from inclement weather and is large enough to hold all the occupants of the primary enclosure at the same time comfortably.

207(h)(2)(x)

Wardens observed puppies in several primary enclosures whose feet were passing through the metal strand flooring.

This warden directs that the kennel owner take the following action(s):

207(h)(2)(x) Have floors that are constructed in a manner that protects the dogs' feet and legs from injury. The floor shall not permit the feet of a dog housed in the primary enclosure to pass through any opening.

207(h)(6)

Wardens observed that the housing facility for dogs was not sufficiently heated to keep the temperature from falling under 50 degrees F.

This warden directs that the kennel owner take the following action(s):

207(h)(6) Housing facilities for dogs must be sufficiently heated and cooled to protect the dogs from temperature or humidity extremes and to provide for their health and well being. If dogs are present, the ambient temperature in the facility must not fall below 50 degrees F. The ambient temperature must not rise above 85 degrees F when dogs are present, unless the requirements of paragraph (7) are met.

A reinspection will take place at a later date.

If a Waiver has been granted regarding a particular section of the Dog Law, this section will be marked N/A. Waiver denials may result in a limited period of time to come in to compliance with a particular section of the Dog Law.
